**Please note the following:**

- Hydro will be provided according to booth location (see layout on page 2). All power must be by hydro: no diesel, gasoline or propane generators will be allowed to run in the park.
- Booth space may not be sublet or shared.
- Merchandise booths are 10'x10'. Vehicles will not be accepted as merchandise booth space.
- No tables, chairs or tents are provided.
- Vendors must be open for business at all times during the following hours: August 9<sup>th</sup> 12pm-11pm, August 10<sup>th</sup> 11am-11pm, and August 11<sup>th</sup> 11am-7pm.
- Proof of \$2 million liability coverage (including public liability, bodily liability, food products liability and property damage with the "Town of Whitchurch-Stouffville" listed as an additional insured) will be requested upon acceptance from all vendors and must accompany contract.
- Please note that if your total vendor fee is not paid by the date specified in the contract, your space will be given to another vendor without notice, and the deposit is 100% non-refundable
- All vendor fees are non-refundable except when the event is cancelled by the Town
